# 2024-25 Financial Report Director of Finance - Mat Bowling

This year has been financially strong. The Club remains in a very healthy position, thanks to continued grant support and resilient sponsorship relationships, even in the face of wider economic challenges.

## Key Highlights:

- Venue hire revenue performed exceptionally well and remains a vital income stream.
- We ended the year with a \$25,000 surplus, slightly below last year. However, a portion of reserves is being intentionally retained to support building maintenance, lifeguarding, and surf sports - a careful balancing act.
- Revenue has increased, as have costs, including payments into our Trust for facility upkeep. Ensuring we have funds available for necessary building work is critical.
- We continue to subsidise surf sports across all levels, from Juniors to Masters. Our goal is a highly engaged membership and careful investment in priority areas.
- The outlook for 2025–26 is strong. Surf Life Saving New Zealand continue to support our life guarding costs, along with some of our administrative costs. Wedding bookings are looking promising for the season ahead.

In summary, the financial outcome is pleasing. Thanks to stable sponsorships, strong venue hire performance, and prudent reserve management, the Club is poised to enter the next





season with confidence. Investments made this year in facilities, patrol operations, and surf sport development position us well for continued progress.


No objections to these nominations so these were accepted as the Board members and President for the period 1/08/2025 - 31/07/2026.
